Subject: **INTERNSHIP PROGRAMME OF THE DEPARTMENT OF DISINVESTMENT FOR UNDERGRADUATES PURSUING FIVE YEAR INTEGRATED COURSE IN LAW; GRADUATES PURSUING POST GRADUATION AND POST GRADUATES PURSUING RESEARCH IN ECONOMIC/FINANCE/MANAGEMENT.**

Department of Disinvestment has the mandate to disinvest Central Government equity in Central Public Sector Undertakings.

2. The Department intends to offer an internship programme for Undergraduates pursuing five year integrated course in law; graduates pursuing post graduation and post-graduates pursuing research in economic/finance/management. The programme will provide an interface with the academic institutions and help to get fresh ideas from the field of academics which will enable the Department to critically analyze its activities and take corrective steps in an objective and impartial manner. It will also simultaneously provide an opportunity to the interns to gain valuable hands-on experience that would let them put their education to work especially in the areas of corporate law and corporate finance and familiarize themselves with the overall process of formulation of disinvestment policy of Government at the macro level.
3. The internship programme is neither a job nor any assurance as such for a job in the Department of Disinvestment.
4. The **guidelines/salient features** of the Internship Programme are as follows:-

Eligibility	The following candidates are eligible for internship <ul style="list-style-type: none">• <i>Students possessing first class graduation degree pursuing Post Graduation, and post-graduates with high second class degree (with at least 55% marks) pursuing Research in Economics/Finance/ Management at National Schools of Economics/Central Universities/ Recognized Financial / Economic Institutions/ Recognized National Management Institutes.</i>• <i>Students with at least 80% marks in 12th Standard pursuing five year integrated course in Law (only in fourth and fifth year of study) from the National Law Schools at Bangalore, Bhopal, Hyderabad and Kolkata.</i>
Duration	Duration of internship will be two months. The interns will be required to attend the programme full time for two months. There will be only one batch of six interns for the internship programme during 2015-16. The programme is likely to commence in early May, 2015.

Selection	All the applications will be scrutinized and shortlisted, in order of merit, by a Selection Committee based on the marks obtained by applicants in class XII and graduation level. In case of a tie, ranking will be done on the basis of marks obtained in graduation. A total of only six interns shall be accommodated in the programme.
Placement	The interns would be attached with the Director/Deputy Secretary in the division of the Department.
Logistics Support	Interns will be provided with the necessary logistics support, i.e., office space and computer with internet facility.
Token Remuneration	A token remuneration @ Rs. 10,000/- per month (total Rs.20,000/-) will be paid to the intern on successful completion of the internship.
Declaration of Secrecy	Interns are required to furnish to the Department a declaration of secrecy before reporting for the internship.
Submission of Paper	The interns will be required to present a Report/Paper on the assigned subject/project at the end of the internship. They will also be required to give a feedback on their experience and suggestions for improvement of the Programme.
Certificate of Internship	Certificates will be issued to the interns at the end of the internship on submission of their Report/Paper.
How to Apply	Interested and eligible students should send their applications, along with their CVs, in the enclosed prescribed format to Under Secretary (Administration), Department of Disinvestment, Room No. 213, Block No. 14, CGO Complex, New Delhi-110003. Last date for receiving of application is 06th April, 2015. Applications received before issue of this advertisement shall not be considered and concerned applicants are advised to submit their applications afresh.
