The quotations should be dropped in the Tender Box kept at the Main Gate of Block No. 14, CGO Complex, Lodi Road, New Delhi latest by 3.00 PM on 11th March, 2016 and the same will opened on the same day i.e. 11.3.2016 at 3.30 PM in the chamber of undersigned i.e. Room No. 213, Block No. 11, (entry from Block No. 14) CGO Complex, Lodi Road, New Delhi. The successful bidder will have to deposit Rs. 1,00,000/- (Rupees one Lakh only) as security deposit in the form of FDR in 7 days of award of the contract and that must have validity beyond 90 days.
